### 3. Qualification & Experience:

The requisite qualification and other relevant information are as tabulated below.

### 4. Remuneration

The consolidated monthly remuneration payable for candidates will be Rs. 28,000/- for those who will be posted at Jammu & Kashmir, Ladakh, Uttarakhand, Sikkim and Arunachal Pradesh. For candidates posted at any other states the consolidated monthly remuneration payable will be Rs. 25,000/-.

## **5. SELECTION PROCESS:**

### **A. Walk-in logistic/Processes**

- a) Before walk-in, candidate must visit ITI Limited website (<https://www.itilttd.in/careers>) and fill the online application form for this notification/advertisement.
- b) All the candidates who have applied through online-mode, may walk-in at the designated location with a print out of the submitted online application on the specified date and time. Candidate must bring copies of their resumes, educational certificates, and any other relevant documents.
- c) Initial screening will be done based on the documents produced by the candidates.

### **B. Assessment for Selection Processes**

- a) During the walk-in selection, candidates will be assessed based on their qualifications, experience, skills, and suitability for the positions available.
- b) Candidates who meet the eligibility criteria will be shortlisted and results will be displayed on the company website.

## **6. CONCESSIONS/ RELAXATIONS**

- a) Reservation of posts for SC/ST/OBC (Non-Creamy Layer)/Ex-servicemen (ExSM)/ EWS will be as per Govt. Directives.
- b) Max Age Limit for Ex-service Personnel: The period of service in Armed forces plus 3 years shall be deducted from the actual age of the ex-service personnel and if the resultant age does not exceed the maximum age fixed for the post, he shall then be eligible for consideration.
- c) The persons with benchmark Disabilities of 40% and above as prescribed in (RPwD Act, 2016) are eligible to apply to the posts earmarked for persons with benchmark disabilities.
- d) ExSM candidates belonging to SC/ST/OBC (NCL) categories shall be eligible for grant of cumulative age relaxation under one/ more categories. Reservations for Ex-servicemen category will be extended on horizontal basis.
- e) SC/ST category candidates applying against unreserved posts shall be considered under general standard of merit and no relaxation upper age limit shall be available to them.
- f) OBC-NCL category candidates applying for any post marked unreserved (UR) shall be considered under general standard of merit and no relaxation in upper age limit shall be available to them.
- g) Candidates belonging to OBC-Non Creamy Layer Category are required to submit latest OBC Non Creamy layer certificate from a competent authority in the prescribed format. Candidates belonging to OBC category but falling in creamy layer (in terms of guidelines issued by Govt. of India from time to time) are not entitled to OBC reservation benefits.
- h) Age relaxation will be provided for reserved posts as follows:
  - SC/ST:- 5 Years
  - OBC-NCL:- 3 Years

## **7. MEDICAL STANDARD**

- a) The work entails field postings at remote locations and the candidate must be physically fit to handle the rigors of the job assigned.
- b) Appointment of selected candidates will be subject to medical fitness duly certified by the Medical Officers of any Government Hospital.

- ix. Valid Income and Asset certificate issued by the Competent Authority in the prescribed format as per Annexure – 1 of DoPT Circular No.36039/1/2019-Esst(Res) dated 31.01.2019 in respect of EWS Candidates.
- x. Copy of Service Certificate in respect of Ex-Defence Service personnel.
