- 6) Latest Form 16 TDS Certificate.
- 7) All proof of experience should be duly certified by the Organization concerned.
- 8) Caste Certificate issued by the Competent Authority in respect of SC/ST category candidates.
- 9) OBC (Non-Creamy Layer) category certificate/ Form of certificate produced by Other Backward classes to apply for appointment to post under Govt. of India (NCL) in respect of OBC-NCL category candidates.
