Textual Information()	ITI is a Central Public Sector Undertaking. The Ministry of Finance vide notification no. GSR 520(E) dated 30.07.2021 has amended the Rule 19A of Securities Contract (Regulation) Rules, 1957 authorizing Central Government to exempt any listed public sector company from any or all the provisions of this rule. Accordingly, the Company has requested its administrative Ministry to do needful so as to exempt the Company from Compliance with Minimum 25% Public shareholding requirement. Meanwhile Department of Economic Affairs, Ministry of Finance vide order F NO.1/14/2018-PM(Part) dated 06.07.2022 had addressed Chairman, SEBI stating every listed public sector company which has public shareholding below 25% and which could not increase its public shareholding to at least 25% within timeline stipulated in Rule 19A of SCRR, 1957 shall get exemption upto 01st August 2024 to increase its public shareholding to at least 25%.
Textual Information()	The Board of Directors in its meeting held on 28.09.2022 has allotted 77,33,204 Equity Shares to the President of India against CAPEX receipt of Rs. 80,00,00,000. The Company has received listing approval from BSE and NSE on 14.10.2022 and 17.10.2022 respectively. Trading application shall be submitted on execution of Corporate Action, which is under progress.
