THE GOVERNMENT'S FISCAL deficit touched 132.4% of the full-year target at Decemberend mainly due to slower pace of revenue collections, official

The deficit was 112.4% of 2018-19 Budget Estimate (BE) in the corresponding period.

According to the CGA, the government's revenue receipts were ₹11.46 lakh crore or 58.4% of the 2019-20 BE. In the same period last fiscal, the collections were 62.8% of the BE. The data further revealed that total expenditure was 75.7% of BE or ₹21.09 lakh crore. During the corresponding period in 2018-19, the expenditure was 75% of the BE.

Of the total spending, the capital expenditure was 75.6% of the BE, higher than 70.6% of the estimates during the same period in 2018-19.

HC sets aside order restraining e-comm majors from selling Amway, Oriflame goods

THE DELHI HIGH Court on Friday set aside a single judge's order restraining e-commerce majors like Amazon, Flipkart and Snapdeal from selling health and beauty products of direct sellers — Amway, Modi-

care and Oriflame — without their consent. Abench of justices S Muralidhar and Talwant Singh quashed the July 8, 2019, interim order of the single judge, saying no case was made out for providing such a relief to

the direct selling entities (DSEs). The court also imposed a cost of ₹50,000 on the direct sellers to be paid to the e-commerce platforms in each of their six appeals. The e-commerce majors, represented by senior advocate Gurukrishna Kumar and advocates Saikrishna Rajgopal and Rajshekhar Rao, had contended in their appeals that the single judge gave broad findings on issues which were not raised in the suits filed by the DSEs. The single judge, justice Prathiba M Singh, in her order, had observed that the goods of the DSEs being sold by the ecommerce giants had inflated MRPs and were tampered with, and that expired products were

being given new manufacturing dates. Justice Singh had also observed that the e-commerce majors have the obligation to maintain sanctity of the contracts and should not encourage or induce a breach.
