ITI Limited holds 437th Board Meeting



TI Limited organized its 437th Board Meeting on August 13, 2018 at Corporate Office, Bengaluru. The meeting was chaired by Shri K Alagesan, CMD and attended by Shri R M Agarwal, Director (Marketing & HR), Shri Chittaranjan Pradhan, Director (Finance), Shri Rajesh Sharma, Government Director, Shri Saday Krishna Kanoria, Independent Director, Smt Asha Kumari Jaswal, Independent Director, Shri Suresh Chandra Panda, Independent Director, Shri CA Rajen Vidyarthi, Independent Director, Shri Akhilesh Dubey, Independent Director, Smt Shanmuga Priya, Company Secretary, Smt Malathy Menon, DGM-Corporate Finance and Shri S K Raina, AFM-CF. The board approved the financial results of the company and declared a profit of Rs. 4 crore for the first quarter ending June 30, 2018. The profit declared is without grants from Government of India. The company has achieved a turnover of Rs. 231 crore for the first quarter of the current financial year 2018-19 as against the turnover of Rs. 198 crore during the corresponding period in the last financial year 2017-18.

ITI Limited Celebrates Nations 72nd Independence Day

TI Limited celebrated the nations 72nd Independence Day across all its plants/units with enthusiasm and patriotism on August 15, 2018. Shri K Alagesan, CMD, ITI Limited unfurled the tricolor national flag after inspecting the guard of honor which was followed by salute and national anthem in the presence of Shri R M Agarwal, Director (Marketing & HR), senior officers, employees, representatives of employees'

union, officers association, family members and ITI school children at corporate office. On the auspicious occasion, Shri K Alagesan recalled the sacrifices of all the martyrs and freedom fighters who won freedom for country from the shackles of British colonialism and paid tributes to them. He extended his wishes to the gathering.

Shri K Alagesan in his address highlighted the performance of the company and said, "The Financial Year 2017-18 has been a breakthrough year for ITI and it is a year of turnaround for making profit without grants after a long gap of 16 years. The performance for the financial year 2017-18 has been phenomenal, as the company achieved a turnover of Rs. 1702 crore which is remarkably the highest turnover in the last seven years.

Without the grants from the Government of India, the net profit for the period before tax increased to Rs. 102 crore for the year ended March 31, 2018 as against a loss of Rs. 56 crore for the previous year. The company has achieved a turnover of Rs. 231 crore for the first quarter in the current financial year 2018-19 against a turnover of Rs. 198 crore for the first quarter during the last year. ITI Limited has made a profit of Rs. 4 crore for the first quarter without any grants from GoI unlike the first quarter profit of last year which was on account of Government grants. As on date, ITI has an outstanding order book of Rs. 2470 crore and Advance Purchase Orders of Rs. 376 crore which should be converted as confirmed Purchase Orders during this year. The company is now on a firm platform from where we expect to propel and drive towards achieving sustained growth."







On the projects front he said, "We are in the process of finalizing the Purchase Order for Rs. 7500 crore deal of Army Static Switched Communication Network (ASCON) from the Ministry of Defence to deploy and maintain Phase IV of the Army's modern communication network across India. ITI has won various mega tenders like MahaNet, GujratNet and West Bengal tender as part of BharatNet Phase II project amounting to Rs. 5000 crore. ITI has also won BNG, DDoS, Radio Modem tenders from BSNL and reservation quota for supply of Wi-Fi equipment. ITI is expecting an order for maintenance of BSNL's GSM network in two circles under reservation quota valued approximately Rs. 5600 crore for a period of 10 years. As a part of implementation of company's revival plan, a number of new projects have been allocated to our plants/ units. In addition to the telecom projects GPON, MLLN, SSTP, Wi-Fi, DWDM, OTN, Radio modem etc., we have started manufacturing of Smart Energy Meters, HDPE duct, Optical Fiber Cable, Solar panels, Mini PC, Set Top Box, Smart Cards, Banking Cards etc. ITI Palakkad has upgraded the infrastructure to manufacture Banking cards and has been accredited by National Payment Corporation of India (NPCI) for RuPay cards. The certification by VISA and Master Card is also in progress. The existing Data Centre of 75,000 square feet area and 350 rack capacity is being upgraded with additional 2,00,000 square feet area and 1000 racks, expecting orders from government agencies for the Data Centre hosting services in the coming days. ITI is setting up telecom testing lab, security lab and SAR testing lab in the Bangalore plant."





Further he said, "We like to be the brand ambassadors for driving GoI initiatives of 'Make in India', 'Digital India', 'Smart City' and 'Start-up-India' under the Ministry of Communications, GoI. With the release of National Digital Communications Policy 2018 (NDCP 2018), ITI expects new business opportunities in the coming days. Company's renewed infrastructure is capable of manufacturing any type of electronic and communication products. ITI plans to manufacture Wi-Fi equipment and Optical Fiber cables in a big way to derive business prospects expected from the upcoming policy. In addition to the projects, ITI is not leaving any stone unturned for enhancing revenue generation through monetization of unutilized land and other facilities in ITI Township. With the support of DoT and Government of India, we have started many initiatives to anchor ITI on a firm platform to sustain its growth. He urged all the employees to accomplish the goal of total turn around and to focus on the mantra "Position ITI - On firm stage from where we launch ITI to reach to the Zenith; Propel ITI - Towards Set Goal by winning & timely execution of projects; Prosper ITI - To achieve and surpass past glory of ITI by sustainable performance and growth".

On the occasion, Shri Alagesan also distributed corporate performance awards to the employees for their outstanding contribution towards the company.

Manufacturing of Solar Photovoltaic (SPV) Modules at ITI Naini Plant

TI Naini Plant has established state-of-the-art technology 18 MW Solar Photovoltaic (SPV) Module manufacturing line. A photovoltaic system is known as PV system or solar power system and is designed to supply usable solar power by means of photovoltaics. A solar panel works by allowing photons or particles of



light to knock electrons free from atoms, generating a flow of electricity. Solar panels are comprised of many smaller units called photovoltaic cells and these cells convert sunlight into electricity.

The SPV manufacturing line consists of major equipments/machines viz. Tabber Stringer Machine, Lay-up Station, Tester, Laminator, Framing and LED Sun Simulator. The manufacturing line has the capacity to produce power of 18 MW/year. The facility has a fully automatic Tabber and Stringer machine ETS700 with patented innovative hybrid soldering system which allows soldering of the photovoltaic cells without thermal stress. The machine is interfaced with Automatic Layup Systems for an automatic pickup and positioning of the



solar cells on the glass. Tester machine enables extensive control of production by continuously monitoring the defects in cells. After testing, the solar panels are laminated in the lamination machine. To laminate a solar panel, two layers of ethylene-vinyl acetate (EVA) are used in the following sequence: glass/EVA/solar cell strings/EVA/ tedlar polyester tedlar (TPT). During the lamination process, the prepared 5-layer module is placed in the lamination machine and heated to maximum 135°C for a period of 18-20 minutes approximately. After the laminate is cooled down, excessive EVA and TPT are cut away and the junction boxes get attached. Finally laminated modules are framed. The LED Sun Simulator is used for testing photovoltaic modules and measuring I-V curve and the technology developed for the equipment uses LED as light source in certification facilities.

Training on 'Cyber Security Awareness' at ITI Palakkad Plant

TI Palakkad Plant organized a one day training program on 'Cyber Security Awareness' to raise awareness about the importance of cyber security for the officers and employees of Smart Banking Card Project on July 5, 2018. Shri S N Vijayarajan, resource person from TimeNet, Kakkanad, Kochi imparted training on various topics like how to protect internet connected systems including hardware, software and data from cyber attacks to 59 officers and employees of ITI Palakkad Plant.



ISO 9001:2015 Certification for ITI Palakkad Plant

ITI Limited Bags Rs.2,658 Crore MahaNet order for Implementation of BharatNet Phase II

TI Limited, a multi-unit central public sector undertaking in the telecommunications manufacturing segment has been selected as the Project Implementation Agency (PIA) for MahaNet-I (BharatNet Phase II) in Maharashtra for two packages, A and C, issued by Maharashtra Information Technology Corporation Ltd. As part of



BharatNet Phase II, MahaNet aims to digitally connect nearly 13,000 gram panchayats to blocks through underground/aerial optical fiber and extend Broadband connectivity to all the gram panchayats using IP-MPLS technology based products and extend broadband to local populace through Wi-Fi hot spots. After ITI bids were declared as the lowest (L1) for both packages earlier this year, ITI has now received Letter of Intent from Maharashtra State Government to execute the project for two packages A and C, in which ITI was L1. Both packages together, ITI will be covering 18 districts, 110 talukas and 8695 gram panchayats. The scope of work for these packages include laying of Optical Fibre Cable (OFC underground and aerial) including site survey, planning, procurement, design, implementation network at talukas and GPs as well as operations and maintenance of the network. It also includes radio connectivity for gram panchayats that cannot be connected through fiber, implementation of horizontal connectivity to government premises, schools and PHCs. Around 38,000 kilometers fiber cable has to be laid, that includes underground and aerial fiber to connect gram panchayats with blocks, district centers and state headquarter.



Highlighting on the implementation of MahaNet, Shri K Alagesan, CMD, ITI Limited said, "With these Purchase Orders expected shortly, ITI's order book will improve substantially. ITI has implemented BharatNet Phase I in several states including Maharashtra and the MahaNet project gives us an opportunity for further contribution to the BharatNet project Phase II." Emphasizing on ITI's contribution to BharatNet project, Shri R M Agarwal, Director (Marketing & HR), ITI Limited said, "ITI's marketing initiatives are driven to supplement GoI missions like Make in India, Digital India, Smart City and Swachh Bharat. After being awarded the MahaNet project for package A & C, we are expecting new business opportunities. With our renewed infrastructure in all our plants, we are capable of manufacturing various types of electronic assembly required for communication products." BharatNet is a Government of India project aimed at providing high speed broadband connectivity to the 2,50,000 gram panchayats in the country augmenting the Digital India initiative under Phase I project, connecting 1,00,000 gram panchayats was completed by December 2017.
