Shri K Alagesan Assumes Additional Charge of Chairman & Managing Director of ITI Limited



Shri K Alagesan, Director (Production & HR) assumed the additional charge of Chairman and Managing Director of ITI Limited on May 31, 2018 following the retirement of previous CMD, Shri S. Gopu.

In his message to all ITI employees after assuming the charge, Shri K Alagesan said "I feel honoured to take the additional charge of Chairman and Managing Director of this esteemed organization after being Director Production for two years with additional charge as Director Marketing for past one and half years. I thank the Government of India and particularly DoT, for showing faith in this company and approving a revival package in 2014. The company has declared profit for the first time after a gap of sixteen years, while we still have severe financial crisis, having huge loans from the Banks and pending statutory dues. We need to work hard to ensure that the darker days of last one and half decades do not reappear."

He further acknowledged that "I am glad to mention that our company has a comfortable order book position winning many mega tenders, like ASCON, BharatNet and Smart Energy Meters and currently our order book is expected to cross Rs. 16,000 Crore. All these mega tenders won by us against stiff competition not only with PSUs but also with major companies in the private and winning these open tenders shows our ability and strength to compete in the open market. And we are further pursuing many more tenders and aim to cross order book over Rs. 20,000 Crore this year."

On work order position, he said "Winning tenders and getting orders is the first step, execution of the orders to the satisfaction of the customers is the next crucial step

and this is most challenging and demanding part of our professional front. As part of implementation of company's revival plan, a number of new projects have been allocated to our manufacturing Plants/Units. In addition to telecom projects, namely, GPON, MLLN, SSTP, Wi-Fi, DWDM, OTN, Radio modem, Antenna etc., we are manufacturing Smart Energy Meters, HDPE ducts, Optical Fiber Cables, Solar panels, Mini PCs, Set Top Boxes, Smart Cards, Banking Cards etc. We are offering variety of software services, like, Data Centre hosting services, Aadhaar authentication services, e-tendering services, core banking applications, mobile tag wallet application etc. We are providing electronic contract manufacturing services in most of our plants, PCB manufacturing services in Bangalore and Palakkad plants, 3-D printing and Injection Moulding services in Bangalore plant, Mechanical fabrication services in all the plants except Palakkad plant, EMI & EMC testing services in Bangalore plant etc."

Highlighting company's financial strength he said "The Company is pursuing for successful execution of Further Public Offer (FPO) to help us in leveraging cash flow. We have a huge sundry debtors aggregating to Rs. 3320 Crore which, if meticulously followed up, should help us to realize significant part of the receivables after adjusting the advance/vendor payment."

On supplementing Governments flagship programs he said, "Being under the Ministry of Communications and Gol, we should be the ambassadors for driving Gol missions on 'Make in India', 'Digital India' and we need to identify more and more products and solutions under these heads. The Company has signed MoU with the Gol and required to achieve a turnover of Rs. 3300 Crore in the current financial year 2018-19."

Concluding his message to all employees he said, "I am confident that you are ready to take up the challenges and will support me in scripting the revival story of this company attaining zenith of performance. I wish you and your family the best for prospective and fruitful days ahead."

ITI Limited Declares Profit of Rs. 102 Crore for the Financial Year 2017-18

ITI Limited has announced a profit of Rs. 102 Crore for the financial year 2017-18. The company has turned green after 16 years and declared profit for the financial year 2017-18. Company's total turnover for the period ended March 31, 2018 was Rs. 1703 Crore as compared to Rs. 1611 Crore for the previous period ended March 31, 2017.
