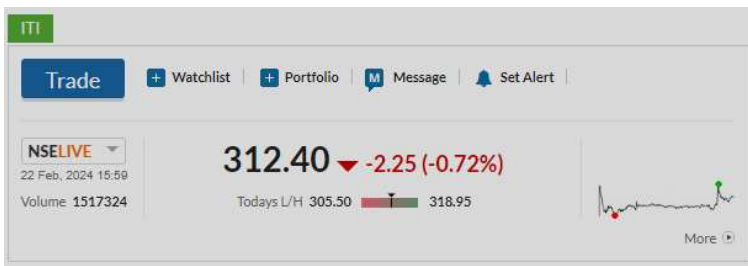

The OS provides access to trusted apps from organisation-specific Private App Store Services (PASS).
