State-run telecom product maker ITI Ltd on Monday (January 13) said it has won contracts totalling ₹64 crore, including a ₹35-crore order from Sambalpur University, Odisha, and a ₹29.14-crore order from Central Railways, Mumbai.

"The company has received orders from Sambalpur University in Odisha for Wi-Fi & LAN worth ₹35 crores, and Integrated Security System from Central Railways worth ₹29.14 totalling ₹64 Crore," ITI said in a regulatory filing.

The Sambalpur University project involves establishing campus-wide Wi-Fi and LAN across 80 locations, with supply, installation, and commissioning, along with three years of maintenance. ITI will provide a secure wireless controller with advanced functionalities to enhance network security and accessibility.


This project includes supply, installation, and commissioning along with a year's maintenance period. ITI will supply a secure wireless controller with additional functionalities like authenticator and restricted unauthorised users, and so on.

The Central Railways contract focuses on implementing an integrated security system with IP-based video surveillance at six railway stations in Mumbai, including Chhatrapati Shivaji Maharaj Terminus, Dadar, and Thane. The project, to be completed within 12 months, includes installing over 1,400 cameras and offers five years of annual maintenance support after the initial warranty period.

"The scope of work includes supply, installation, testing and commissioning of integrated security system consisting of IP based video surveillance system at six railway stations of Mumbai division viz. Chhatrapati Shivaji Maharaj Terminus, Dadar, Kurla, Lokmanya Tilak Terminus, Thane and Kalyan of Central Railways, and AMC for five years after the expiry of the warranty period of three years," ITI said.
