ITI Limited scales new heights of performance, clocks turnover of Rs 1621 Cr

ITI Limited, India's first PSU and a pioneering venture in the field of telecommunications has reported consolidated turnover of Rs 1621 Crores for the financial year 2016-17. It is remarkably the highest turnover in the past six years, which is around 30 % increase over last fiscal year.

Commenting on the performance of the company, Shri S Gopu, Chairman and Managing Director, ITI said, "This performance is an indication of the company treading on the path of Revival and we are setting much bigger targets to achieve better results in the coming years. This robust performance in an economically difficult time was due to the untiring efforts made by the employees in accomplishing the projects in stipulated time.
